Here is how to respond if you get served a foreclosure complaint & summons. (The document you receive when a foreclosure lawsuit is filed against you) Please know, filing an answer may not be the best option. Ideally you want to see if you can get the case dismissed before acknowledging the lawsuit.

Whether you Defend Your Own Foreclosure Lawsuit or decide to hire a lawyer to help, it's important to know what documents are involved and what to expect if you do hire an attorney. Sample Foreclosure Letters When you're served with a foreclosure lawsuit, some type of response is typically due within 20 or 30 days depending on the state you're in.

I need a sample letter of how to respond to a foreclosure summons. I am currently in the middle of a loan modification with the bank, yet, the proceedings are still going forward. I am trying to keep the house and the bank is finally working with me, but, I still have to respond to the courts. Any suggestions of how to respond.

There is no standard format used to answer a foreclosure summons in California. Your response should simply be a letter to the court confirming or denying the allegations stated in the summons ...

A foreclosure summons is a legal document issued by the court once the lender starts the foreclosure that notifies you of the case and requires an answer. You only have a specific period of time, as set by the court system, to file your response before the court moves the foreclosure forward.

Each jurisdiction has different rules and attitudes. The answer is just a legal response point by point vs your letter which is more I would think for mediation or a settlement conference often ordered by the Court but again depends on local procedures. See my example of a response although its a credit card situation but should give you idea at

Even if you are already in the process of working out a solution with your bank, you may receive formal (legal) notice that the foreclosure process has begun. The following is an example of an answer to foreclosure complaint: IN THE CIRCUIT COURT OF THE SIXTH JUDICIAL CIRCUIT IN AND FOR SEMINOLE COUNTY FLORIDA GENERAL JURISDICTION DIVISION.
