

# Download Letter Minor Traveling

A Travel Consent Letter is used when a child is traveling alone, with only one parent/legal guardian, or with an authorized group. This document notifies authorities or other interested parties that a parent or legal guardian has given their consent for the child to travel without them.

The child travel consent form is used for any minor that has permission from their parent or legal guardian for domestic or international travel with someone else, group, or organization. In addition, this is also common when the child is traveling alone. It's preferred to have the consent form signed by both parents although one (1) is sufficient.

Minor travel consent form giving parental authorization for child to travel with another person or only one parent. ... An immigration officer, airline, or travel company may ask for a letter of consent if the child is traveling internationally with only one parent or with another adult, such as a relative, friend, teacher, etc.

officer, airline, or travel company may ask you to provide some form of letter of consent if your child is traveling internationally with only one parent or with another adult, such as a grandparent, aunt, uncle, etc. The sample letter below is a guide only. You may also wish to have the letter of consent notarized.

If you should lose or misplace your letter, and have travel that requires the document, visit your local Mexican Embassy or Consulate to coordinate the replacement of the letter. The parents or guardians of the minor who is traveling will need to complete a new Letter in their home country and have it sent to Mexico to facilitate such travel.

Therefore, your child will likely be asked by an immigration officer or airline staff member will ask for a letter of consent if he or she is traveling without both parents. A Child Travel Consent Form is a legal document that allows a minor child to travel without both parents or legal guardians present.

Protect your child's safety when traveling. Use a Child Travel Consent form to provide guardianship permission for your minor child if you and your spouse are separated or divorced, or if your child is travelling with grandparents or other family members.
