Panama Highlights 2018. Rate – Tax is assessed at the greater of a 25% flat rate on net taxable income or a 1.17% rate on gross taxable income; the latter is the alternative minimum tax (CAIR) (see below under “Alternative minimum tax”). Surtax – No. Alternative minimum tax – The CAIR is assessed at a general rate of 1.17% on gross taxable income.

Panama Business, Taxation and Offshore Information. Panama was part of Colombia until 1903, when, with backing from the United States, it declared its independence. The USA gained the rights to start working on a canal. Work began in 1903 and was completed in 1914. In 1999, the canal and all its US facilities and bases reverted to Panama, lending a major economic benefit to the country.
